#### 5. Admission Requirements

- timely submission of a binding registration
- payment of the entry fee by the stipulated date
- completion of insurance in accordance with Section 43 (2), (3) LuftVG, registration in accordance with Art. 14 DVO (EU) 2019/947 and/or proof of the required knowledge in accordance with Section 21f (2) LuftVO
- proven skills to safely pilot a speed model aircraft
- proper marking of all models with more than 250g take-off weight by means of E-ID

## 6. Rules

- maximum flying weight: 25 kg
- maximum wing area: 500 dm<sup>2</sup>
- maximum wing load: 250 g/dm<sup>2</sup>
- maximum terminal voltage for electric motors without load: 100 volts with VDE-compliant contact protection

The following classes will be flown:

- fixed-wing gliders up to 25kg take-off weight with electric and combustion engines;  
maximum wing load: 250 g/dm<sup>2</sup>; maximum terminal voltage for the drives without load: 100 volts (with VDE-compliant contact protection)
- helicopters up to 25kg take-off weight with electric and combustion engines; maximum terminal voltage for the drives without load: 100 volts (with VDE-compliant protection against accidental contact)
- (if permission is granted) helicopter night speed flight up to 25 kg take-off weight with electric drive; maximum terminal voltage for the drives without load: 100 volts (with VDE-compliant protection against accidental contact).

## 7. Applications and Registration Deadline

The event will be held as an invitational competition. Applications by e-mail to [ktmoldtmann@t-online.de](mailto:ktmoldtmann@t-online.de) Pilots on the entry list will receive a confirmation by e-mail. Participants from previous years' events will be given priority.

End of registration deadline: 31 December 2023, 00:00 hrs., (time stamp of email receipt).

On 01 February 2024, all accepted participants will receive a confirmation by e-mail. If the maximum number of participants is exceeded, a waiting list will be set up. A place on the waiting list will be confirmed by email.

## 8. Entry Fee

Irrespective of a registration confirmation, the right to take part in the competition only arises if the entry fee is received by its due day. The entry fee is **EUR 125,00** for each participating pilot.

Fail-save must be available on all models and programmed to "engine off".

Further regulations will be issued by the flight director.
